310 Kenneth Welch Drive - Continued discussion regarding proposed operation of Nature's Remedy (retail sales of medical marijuana). The owner of the property will have two Title V inspections done on the property. There is an approved plan and as-built from 1993 for 50 employees. However, the Certificate of Compliance was never signed. Agent Bernardo had noted that the kitchen may require a grease trap. A letter is to be drafted to the ZBA which will mention the agreed upon open door policy, which will allow the Health Agent to enter and inspect the building and/or kitchen at any time. Chairman Poillucci noted that the State law allows municipalities through the Board of Health have the option to adopt additional regulations to provide local oversight. There was a discussion regarding proposed regulations and a letter to be drafted to the ZBA.

Upon a motion made by Member Maxim, seconded by Member Spratt it was:

Voted: to send a letter to the ZBA regarding Nature's Remedy medical marijuana petition at 310 Kenneth Welch Drive. Letter is to state: owner has agreed to do a Title V inspection on the two septic systems involved and to possibly install a grease trap. The Board of Health must approve area for all waste stock piling on-site prior to operation. Operators must consent to unannounced periodic inspection of the dispensaries or the kitchen to the BOH. Pre-approved hours of operation by the BOH and Selectmen prior to approval. Must submit a final plan for review and approval by the BOH. Unanimous approval.
