

**Board of Health Meeting Minutes
December 7, 2011**

The Lakeville Board of Health held a meeting on **December 7, 2011** in the Lakeville Town Office Building. Present at this meeting were Board Members Robert Poillucci, William E. Garvey and Terrence Flynn. Also present were Health Agent Lawrence Perry and Board of Health Clerk Jo Lima as Recording Secretary.

Chairman Poillucci called the meeting to order at 6:00 p.m. and noted that this meeting was being recorded by Clerk Lima and Comcast, and would be televised by at a later date.

Chris Buckley

Homeowner Chris Buckley and David Marangi from Fieldstone Residential were present. This property has a shared well with 25 Pickens St. Septic Design on file is for three bedrooms. A letter was received from Pilling Engineering Group, Inc. requesting the following:

Local Lakeville Board of Health Regulations Variances

1. **Section 12.1** - To reduce the distance from an existing well to an existing property line from 10' to 0'.
2. **Section 12-1** - To reduce the distance from an existing well to an existing street layout line from 20' to 3'.
3. **Section 12.5** - To allow the continued use of an existing shared well.

Upon motion made by Member Garvey and seconded by Member Flynn, the Board:

VOTED: To grant the request with the stipulation that a deed restriction be recorded with the Plymouth County Registry of Deeds stating that the well is an existing "shared well" with property at 25 Pickens St., before the release of the Certificate of Compliance. Unanimous vote in favor.

VOTED: To approve the requests with the following stipulations:

1. A Registered Land Surveyor stamp **is required on the proposed plans.**
2. The Board of Health approval needs to be submitted to the **Department of Environmental Protection (DEP)** for their approval for use of the "Tight Tank
3. A deed restriction must be recorded at the Plymouth County Registry of Deeds stating that the **The dwelling will remain a "Seasonal" (3) three-bedroom dwelling with no further expansion and no increase in flow to the septic system, and it is to be made known that this dwelling houses a "Tight Tank" that requires a Quarterly Inspection Contract for the life of the system to include pumping (maintenance) as necessary, but not less frequently than monthly when dwelling is inhabited.**
4. A **Two Year Renewable Service Contract** with a **"Town of Lakeville Licensed Septage Pumper/Hauler"** needs to be submitted to the Board of Health Office before the issuance of the Certificate of Compliance for the septic system.
5. A **Quarterly Inspection Agreement** acceptable to the Board of Health needs to be submitted to the Board of Health Office prior to the issuance of the Certificate of Compliance for the septic system.

Board Members had a discussion regarding an after-the-fact Local Upgrade Approval. The original proposed plan was approved with his water supply line to be relocated 10' away from septic tank and sewer pipe; however, his installer deviated from that specification.

VOTED: To grant an After -the-Fact Local Upgrade Approval to locate septic components closer than required setbacks subject to the As-Built being submitted. It was also voted to send the installer (Coots Bros) a letter advising him that in the future he should seek permission from the Board of Health Agent, prior to deviating from approved plans. Board members reviewed a proposed plan by Azor Land Sciences, Inc. requiring local upgrade approvals for two divergences from Title V Regulations to site new tanks and leaching system within 200' of a tributary (Loon Pond) at the Ted Williams Camp.

Upon motion made by Member Garvey and seconded by Member Flynn, the Board:

VOTED: To approve the proposed plan with the stipulation that another observation hole and percolation test in primary SAS area will be done during open hole inspection. Unanimous vote in favor.

157 Bedford St.**025-004-001****Tamarack Wine & Spirits**

Mr. Donnelly from Tamarack Wine and Spirits was not present for discussion, but questioned in an email to Clerk Lima why he was paying \$200 for a food establishment license, when he only carries pre-packaged items and does not do any food handling. Chairman Poillucci wasn't comfortable addressing this issue at this time until some research is done in regards to how long it takes Agent Perry to do inspections for establishments that have larger facilities than others. Member Garvey agreed that it would not be fair for a retail establishment to be charged the same fee as a restaurant. Member Flynn stated that we could possibly implement different levels of fees. The Board decided to table this discussion due to the fact that any changes in fees would have to be publicized and a hearing would have to be held. Board Members asked that some research be done to inquire what surrounding towns are charging for fees so that this issue can be addressed at a future meeting.

Board of Appeals Petition for Hearings**49 Myricks St.****005-001-020****Lisa & John Kyranos**

Board Members reviewed the Petition for Hearing for Lisa & John Kyranos. Chairman Poillucci stated that the way the petition was written it appeared that they were wanting to build a two family dwelling, but what they are building is an in-law. The currently submitted ZBA plans do not show sufficient details for an actual BOH approval at this time for septic and well permits however, the Board can give preliminary approval at this time for the recent concept plans reviewed that show the basic layout for this proposed project.

Upon motion made by Member Garvey and seconded by Member Flynn, the Board:

VOTED: To send the Board of Appeals a letter; stating that the Board Members will address this issue when the application/plan/permit packages are submitted for the well, septic and building permits.
