

**TOWN OF LAKEVILLE**  
**Selectmen's Meeting Minutes**  
**May 29, 2007**

On May 29, 2007, the Board of Selectmen held a Special Meeting at the Lakeville Senior Center to review the FY 08 Budget. The meeting was called to order at 6:06 PM. Present were Selectman Yeatts, Selectman Evirs, and Town Administrator Rita Garbitt. Also present: Town Accountant Cynthia McRae and Finance Committee Chair Martha Green.

After reviewing the FY 08 Revenue and Expense Budget Summary, the following recommended budget reductions were agreed upon: Board of Health \$2,939, Park Department \$5,000, Legal Expense \$10,000, Elections \$1,500, Special Education \$10,000, and the Town Office/Fire Station \$10,000. It was agreed that Ms. Garbitt would check with Middleboro G & E regarding the street lights, and Finance Committee Chair Green would check with Plymouth County regarding the prisoners.

At 7:00 PM, upon a motion made by Selectman Evirs and with Chair Yeatts stepping down to second and stepping back up to vote, the Board

VOTED: To continue their budget meeting until after the Public Hearing for the Public Safety/Town Office Building Feasibility Committee.  
Unanimous in favor.

After the Public Hearing, at 8:13 PM, upon a motion made by Selectman Evirs and seconded by Selectman Maksy, the Board

VOTED: To continue their budget meeting.  
Unanimous in favor.

Present were Selectman Yeatts, Selectman Evirs, Selectman Maksy. Also Present: Finance Committee Members Martha Green, Gary Mansfield, Robert Hill, Richard Velez and James Hanlon; Town Accountant Cynthia McCrae; Local School Committee Member Lorraine Carboni; and Regional School Committee Member Robert Canessa.

Chair Yeatts reviewed the Warrant Article for the Annual Town Meeting regarding the sewer project for the shorefront communities. Ms. Garbitt presented the updated FY 08 Budget Summary.

At 9:00 PM, upon a motion made by Selectman Evirs and seconded by Selectman Maksy, the Board

VOTED: To enter Executive Session and not return to Open Session for the purpose of discussing potential litigation and pending litigation.  
Polled vote: Selectman Maksy—Aye, Selectman Evirs—Aye, and Selectman Yeatts—Aye.

At 9:01 PM, upon a motion made by Gary Mansfield and seconded by Robert Hill, the Finance Committee

VOTED: To enter Executive Session and not return to Open Session for the purpose of discussing potential litigation and pending litigation.
