Board of Selectmen
Meeting Minutes
May 7, 2021 – 6:30 PM
REMOTE LOCATION**

On May 7, 2021, the Board of Selectmen held a meeting at 8:00 AM remotely from various locations. The meeting was called to order at 8:00 AM by Chair Fabian. Selectmen present were: Chairman Fabian, Selectman LaCamera and Selectman Carboni. Also present was Clorinda Dunphy, Human Resources Director. LakeCAM was recording the meeting for broadcast.

New Business

Michael O'Brien, Fire Chief, was present for the discussion. Chairman Fabian noted that the Fire Chief has presented two (2) job descriptions to the Board that he would like to get approved. She noted that this vote will need to be ratified at the next Selectmen's Meeting.

Upon a motion made by Selectman Carboni and seconded by Selectman LaCamera, it was:

VOTED: To approve the job descriptions for Fire Lieutenant and Firefighter/Paramedic as presented.

Roll call vote: Selectman Carboni – aye; Selectman LaCamera – aye and Chair Fabian – aye.

Old Business

Chair Fabian wanted to offer some clarification on two issues from a previous meeting. Regarding the mulch purchase for the islands at the intersection of Route 18/105, the money to purchase the mulch was taken from a gift account.

In regards to why two (2) of the Junk Dealer and Junk Collector locations were not inspected, she consulted with the Town Clerk, who issues the licenses, and Nathan Darling, Zoning Enforcement Officer. Mr. Darling stated that these activities are licensed by the Town Clerk and Board of Selectmen. Either party could request an inspection of the locations, but it is not required.
