### 2. Old Business.

#### A. DOR Alert.

Bob Marshall summarized a DOR alert which requires town's by July 1, 2019 must be in compliance with a warrant article for town meeting. Bill August, Esq., has language for the warrant article that will ear mark the funds only to be used LakeCAM and not other Lakeville Town Departments.

#### 3. New Business.

#### A. Verizon Police Station Connection.

Peter Epstein, Esq., does not agree with Jose Invencio and Bob Marshall's assessment of what Verizon had agreed to do for the connection between the new police station and LakeCAM. Mr. Epstein recommended that the Board of Selectmen through the Cable Advisory Committee write a letter to Version requesting Verizon respond in writing to requirements of Section 5.15 of the contract between the Town of Lakeville and Verizon.

The Board of Selectmen have agreed that a fiber can be used by LakeCAM to connect the new police station, LakeCAM, and Emergency Management. Verizon will be providing an encoder and a decoder, valued at \$2,500 each, to the town. Ian Lewis stated that TMLP shall provide two (2) media convertors and

the actual redirection of the fiber – this is a normal service provides to TMLP customers.

## B. Approval of Letter Drafted by Peter Epstein, Esq.

A motion was made By Tom Cirignano seconded by Ian Lewis to approve a letter drafted to Paul Trane by Peter Epstein, Esq., for the Cable Advisory Committee to present to the Board of Selectmen concerning the Police Station PEG Access Studio Connection.
