

## **Cemetery Commission MEETING MINUTES**

November 12, 2009

Meeting called to order at 4:00PM by Chairman Upham.

Members present: Commissioners Brad Bates.

Guests present: None.

Minutes of Meeting held on August 12, 2009 were read and approved. The minutes were entered into the Towns Records and Website.

### **Unfinished business:**

A: The Installation of granite posts at Clark Cemetery is scheduled for spring 2010. This will allow sufficient time to acquire additional donated posts from Mr. Emil Maksy. Approved and 2<sup>nd</sup>.

B: Commissioner Bates and another volunteer will assist in repairing and painting cemetery signs over the winter months. Approved and 2<sup>nd</sup>.

C: It is agreed after discussion that foundations will only be done by our town appointed grave diggers at a charge to the citizens of \$92.00 a square foot. Veteran markers furnished by the government will be installed free of charge. The town will receive on a 3 foot foundation \$100.00, on a two foot foundation \$75.00 and for a one foot foundation \$25.00. The remaining money would be paid to the town grave digger who approved of these fees. Approved and 2<sup>nd</sup>. Commissioner Upham will meet with the Selectmen to present this additional charge for services. Approved.

D: A letter will be sent to Mr. Frank Wills, LaBarron Golf Course requesting he full-fill his intentions to furnish boundary trees for Precinct Cemetery in a meeting with the commissioners on April 15, 2009. It will be requested that the trees be furnished to the highway department by March 15, 2010. Approved and 2<sup>nd</sup>.

E: The issue of commissioners reporting monthly on their assigned cemeteries is tabled until the next meeting. Approved and 2<sup>nd</sup>.

F: In reference to the final taking of cemeteries by eminent domain it is agreed that all official references to this issue be obtain and then presented to an attorney for completion. Commissioner Upham will seek and obtain these references. Approved and 2<sup>nd</sup>.

G: The meeting between Commissioner DeMoranville and Mr. Allen is tabled until the next meeting. Approved and 2<sup>nd</sup>.

H: It was agreed than any incidents involving the cemeteries will be reported to the Chief of Police as they occur. Approved and 2<sup>nd</sup>.

Page 2, Cemetery Commission Minutes of November 12, 2009, Continued:

I: Douglas Cemetery was discussed and the need to send Mr. Ron Barber a letter asking for his up-date on the progress being made to identify the boundaries of the cemetery and what has been done to protect it during his construction of the home sites. Tabled until the next meeting. Approved and 2<sup>nd</sup>.
