Conservation Commission Meeting Minutes June 22, 2010

The Conservation Commission held a meeting on June 22, 2010 in the Lakeville Town Office Building. The meeting was called to order by Chairman Orrall at 7:00 p.m. Members present were Bob Bouchard, Joseph Chamberlain, Emery Orrall and Martha Schroeder. Tara Martin, Conservation Agent and Jennifer Jewell, recording secretary were also present. Randall Kenney and Pam Rasa were absent.

7:00 P.M. - 427A Bedford Street

Chairman Orrall read the legal notice. Linda O'Buchon presented a Notice of Intent for the installation of a septic system. There was a review of the plans. Ms. Martin verified the wetland line in the field. It was noted that this plan has received approval from the Board of Health but is awaiting approval from the Department of Environmental Protection. It was suggested that nitrogen absorbing plants be used along the edge of the yard. Upon motion made by Member Chamberlain and seconded by Member Schroeder the Commission

VOTED: To close the hearing and issue an Order of Conditions with the following special conditions: :
1.) The Order of Conditions must be recorded at the Plymouth County Registry of Deeds and a stamped receipt returned to the Lakeville Conservation Commission (LCC) before work begins;
2.) Erosion barriers to be installed and inspected by the LCC agent prior to the start of any activity and remain in place until all disturbed areas have been stabilized;
3.)Plantings should be nitrogen removing per the list provided;
4.) Access to the property will be granted to the LCC and/or its agents, for site inspections, to determine that the project is in compliance with this Order of Conditions. Unanimous vote.

7:07 P.M. – 125 Staples Shore Road

Chairman Orrall read the legal notice. Jeff Youngquist, from Outback Engineering, presented a Notice of Intent to raise the existing dwelling and for the installation of a septic system. There was a review of the plans and site photos. It was stated that the dwelling currently sits on concrete pilings and will be raised approximately 5 ¹/₂ feet. Concern was voiced regarding the amount of fill being added to the site. The elevations and height of the stone wall were reviewed. There was discussion regarding the extent of the rubber liner to be used with the stone wall. Ms. Martin discussed the site visit. There was question as to viable alternatives for this project and the impact of allowing similar work on neighboring lots. Upon motion made by Member Chamberlain and seconded by Member Bouchard the Commission

VOTED: To close the hearing pending receipt of approval from the Department of Environmental Protection and issue an Order of Conditions. 1 in Favor. 3 Against.
