# Conservation Commission Meeting Minutes November 9, 2010

The Conservation Commission held a meeting on November 9, 2010 in the Lakeville Town Office Building. The meeting was called to order by Chairman Orrall at 7:00 p.m. Members present were Bob Bouchard, Joseph Chamberlain and Emery Orrall. Pam Rasa, Associate Member; Tara Martin, Conservation Agent and Jennifer Jewell, recording secretary were also present. Martha Schroeder was absent with prior notice

### 7:00 P.M. - 6 Race Course Road

Gould

Chairman Orrall read the legal notice. Paul Gould presented a Request for Determination of Applicability for the construction of a paddock, riding ring and barn. There was a review of the plans and the previous filing for this site. Mr. Gould noted that the wetlands have been flagged and the proposed work is reflected on the plans. Catch basins and nitrogen absorbing plants will be utilized. Ms. Martin discussed a site visit that was attended by the Department of Environmental Protection. It was stated that most of the proposed work was relocated out of the buffer zone. There was discussion regarding the stormwater flow on the site. It was stated that the manure storage area will be covered and will be located upgradient of the sheet flow area. The adjacent pond currently undergoes testing and the applicant will be made aware of any change in nitrogen levels. Richard Dube and Ann Golden, abuttors, voiced concern regarding the number of horses on the site. It was stated that regulating the number of horses allowed per lot fell under the jurisdiction of the Board of Health (BOH). Upon motion made by Member Chamberlain and seconded by Member Bouchard the Commission

VOTED: To close the hearing and issue a Negative Determination of Applicability. Unanimous vote.

### **MJSN Realty Trust**

Chairman Orrall read the legal notice. Jon Pink, from AZOR Land Sciences, presented a Notice of Intent for the construction of an addition, installation of a septic system and all associated grading. There was a review of the plans. The existing building will be converted to a residence. It was stated that the project must obtain approval from the Zoning Board of Appeals (ZBA). Portions of the pavement will be removed and replaced with lawn. Past violations on the site were discussed. It was stated that the dwelling will be serviced by a three bedroom septic system and will have a crawl space foundation. Upon motion made by Member Chamberlain and seconded by Member Bouchard the Commission

VOTED:

To close the hearing and issue an Order of Conditions with the following special conditions: 1.) The Order of Conditions must be recorded at the Plymouth County Registry of Deeds and a stamped receipt returned to the Lakeville Conservation Commission (LCC) before work begins; 2.) Erosion barriers to be installed and inspected by the LCC agent prior to the start of any activity and remain in place until all disturbed areas have been stabilized; 3.)Access to the property will be granted to the LCC and/or its agents, for site inspections, to determine that the project is in compliance with this Order of Conditions.
