The Conservation Commission held a meeting on April 9, 2013 in the Lakeville Public Library Conference Room. The meeting was called to order by Chairman Orrall at 7:00 p.m. Members present were Robert Bouchard, Joseph Chamberlain, Linda Grubb, Emery Orrall, Pam Rasa, Martha Schroeder and Ryan Trahan. Jamie Bissonnette presented a deed restriction to the Commission. The restriction was reviewed. It was decided that the term "Any dead, diseased or exotic invasive vegetation..." would be added to the document. Upon motion made by Member Schroeder and seconded by Member Rasa the Commission

VOTED: To accept the Declaration of Restrictions as amended and require proof of recording with the

Plymouth County Registry of Deeds. Unanimous vote.

#### **Vigers Stewardship Plan**

The Vigers Stewardship Plan was presented to the Commission by Associate Member Kulakovich and Member Grubb. The Commission reviewed the plan. It was stated that all site work will be done by volunteers at no cost to the town. There was a review of the current conditions of the roadways and stone walls. It was suggested that the Building Inspector verify whether the Boy Scout house should be removed for safety reasons. If possible the foundation could remain in place and serve as the location for a future pavilion. It was stated that some residents are hesitant to access the property due to a 'bow-hunting only' sign. It was stated that this is in effect during bow-hunting season only.

The property will be identified as being owned and operated by the Town of Lakeville. The educational facets of the stewardship plan were reviewed. Recreational camping and a forestry study program may be offered in the future. It was noted that the following are priorities for developing the park: establishing and marking the boundaries, verifying the safety of the Boy Scout house, signage for the roadway/crossing. Member Grubb mentioned that a permitting process should be in place for overnight camping and other events. The current target audience will be families with young children as the park is currently available for picnics and limited use. Member Chamberlain voiced concern regarding parking and roadway crossing. Ms. Yeatts will speak with Chris Peck, Superintendent of Streets and Dan Hopkins, Fire Chief about the Boy Scout house. Upon motion made by Member Grubb and seconded by Member Rasa the Commission

A draft version of the by-law and comments will be available for review at the May 14<sup>th</sup> Conservation Commission meeting. There was discussion regarding an informational session for the general public. It was suggested that a Commissioner could contact the Middleboro Gazette to prepare a press release.
