MASTER PLAN IMPLEMENTATION COMMITTEE
Meeting Minutes
October 29, 2019

On October 29, 2019, the Master Plan Implementation Committee held a meeting at 7:00 PM at the Lakeville Board of Health Office. The meeting was called to order by Chairman Dixon at 7:03 PM. Members present: Rodney Dixon, James Rogers, Rita Garbitt, Patrick Marshall, Sylvester Zienkiewicz and Joseph Chamberlain. Member Absent: Fred Beal. Also present: Town Administrator Maureen Candito and Jed Cornock from Southeastern Regional Planning and Economic Development District (SRPEDD). LakeCAM was recording the meeting.

Member Rogers informed the Committee the Lakeville Helping Lakeville social media page is using the information in Mr. Cornock's handouts to defend their Facebook postings regarding different issues.

Meet with Jed Cornock from SRPEDD to discuss the Goals and Objectives regarding Services & Facilities and Transportatin & Circulation, the Chapter Maps; and the Update from the Assessors on Chapter Land.

Mr. Cornock distributed the updated Chapter Sheets and four (4) Lakeville Roadway Maps: Roadway Networks by Jurisdiction; Intersection Crashes 2001-2015; Bicycle, Pedestrian & Transit Networks; and Facilities & Services. During the review of the Town Accepted Roadways, it was mentioned Surrey Drive was not included. Ms. Candito will contact the Superintendent of Streets, Franklin Moniz, and request he review the Map and update it.

The Committee reviewed the Chapter 7 Data for Services & Facilities. Under Goal 7-2 for Municipal Facilities, Strategy 7-2-4 was added for the Highway Department Facility. Under Goal 7-3 Residential Tax Burden, grant funding will be added. Chapter 8-Transportation & Circulation: The Committee had a lengthy discussion regarding the need for a Traffic Study Committee and the funding for Route 79. Under Strategy 8-2-3 change the word update to investigate.

The next step is to review all of the Chapter Revisions and the Implementation Chart at the next meeting.

Mr. Cornock stated the Assessors' new parcel layer is almost done. He is still waiting for the update on the Chapter Lands.
