# Notes for Wednesday, July 1, OSC, 7pm

- Jesse opened the meeting by reading the announcement of Open Meeting rules followed by the meeting minutes from May 6; there was no quorum for a meeting in June. Jesse asked for any comments from the May minutes, none were heard. Motion to accept the minutes was made by Brian Reynolds and seconded by Mike Schroeder. On roll call vote the minutes passed unanimously.
- Motion by Liz Nash was then made to admit Adam Young as full member. Motion was seconded by Brian Reynolds, and passed unanimously on roll call vote.
- Mike mentioned she was having technical difficulties working on the Open Space Committee Plan. Some suggestions were offered at troubleshooting. Jesse noted that Liz Nash and Christina Barefoot have been recently granted access to the document.

- Chairman Jesse Medford opened the meeting at 7:05pm. Selectman Fabian took attendance and read the rules and instructions regarding remote meetings.
- Selectman Fabian motioned that we discuss real estate issues related to 73
   Howland Road and Lakeville Country Club in executive session. This motion was put to a vote with all members in favor.
- Selectman Fabian mentioned that she had read a letter previously sent to the Board of Selectman by Mike Schroeder on behalf of the committee regarding Lakeville Country Club. The letter indicated several reasons why it might be well-suited for preservation rather than development.
- Selectman LaCamera remarked that the sale was a surprise to them, that there had been no communication with the current owner. The developer plans to build a distribution center. Selectman LaCamera notes the Town has no authority to negotiate on price once a sale has been agreed to, and that it is unlikely they could match the sale price because it would require a tax increase to finance, as no grant money from other sources have been secured.
- Nate Darling noted that a large percentage of the property would not be developed even if 40 acres or so were developed for the distribution center. He also notes that tf the land was instead sold for residences, the situation would be much worse in his opinion.
- Brian R. asks whether Community Preservation Act could be adopted. Selectman
  Fabian wondered aloud why the town rejected it repeatedly in Town Meeting. She
  says we should look into it in the future. Brian points out that Lakeville has lost 130
  old houses in his lifetime; 1/3 of the houses on the historical inventory are now gone.
