

Dear Ms. Drake:

Articles 12 and 13 - We approve Articles 12 and 13 from the May 8, 2023 Lakeville 2023 Annual Town Meeting. 1

Under Articles 12 and 13 the Town recodified its general and zoning by-laws, respectively. The recodification includes renumbering, recaptioning, and repositioning and comprehensive revisions as set forth in the Final Draft of the Code of the Town of Lakeville, dated March 2023. . . ." Our approval of the recodified general and zoning by-laws is limited solely to those changes that were identified in the document submitted to this Office and does not include any other changes.

Pursuant to G.L. c. 40, § 32, neither general nor zoning by-laws take effect unless the Town has first satisfied the posting/publishing requirements of that statute. Once this statutory duty is fulfilled, (1) general by-laws and amendments take effect on the date these posting and publishing requirements are satisfied unless a later effective date is prescribed in the by-law. and (2) zoning by-laws and amendments are deemed to have taken effect from the date they were approved by the Town Meeting, unless a later effective date is prescribed in the by-law.

¹ In a decision issued August 11, 2023 we approved Article 11 and by agreement with Town Counsel pursuant to G.L. c. 40, § 32, we extended our deadline for a decision on Articles 12 and 13 for an additional ninety days until November 14, 2023.
