Dear Ms. Drane:

Article 11 - We approve Article 11 from the May 8, 2023 Lakeville Annual Town Meeting.

Articles 12 and 13 - The Attorney General's deadline for a decision on Articles 12 and 13 is extended for an additional 90 days under the authority conferred by G.L. c. 40, § 32. The agreement with Town Counsel for a 90-day extension is attached. We will issue our decision on Articles 12 and 13 on or before **November 14, 2023**.

Note: Pursuant to G.L. c. 40, § 32, neither general nor zoning by-laws take effect unless the Town has first satisfied the posting/publishing requirements of that statute. Once this statutory duty is fulfilled, (1) general by-laws and amendments take effect on the date these posting and publishing requirements are satisfied unless a later effective date is prescribed in the by-law, and (2) zoning by-laws and amendments are deemed date they were approved by the Town Meeting, unless a later effective date is prescribed in the by-law.


