

# SPECIAL TOWN ELECTION

June 28, 2022

A Special Election of the Town of Lakeville was held at the Ted Williams Camp, Loon Pond Lodge, 28 Precinct Street in accordance with the warrant issued by the Selectmen and properly posted by a constable of the Town.

Specimen ballots, penalty and instruction cards were posted in accordance with the law. The ballot boxes were inspected, found to be empty, and registers were set at zero. All election officers were sworn to the faithful performance of their duties.

The polls were declared open at 12:00 PM and closed at 8:00 P.M. in accordance with the Warrant. There were **1812 ballots cast**, including 80 absentees. Precinct One had 503, Precinct Two had 661 and Precinct Three had 648 Preliminary totals were announced about 8:10 P.M. by the Town Clerk and they were as follows:

**Question:** Shall the Town of Lakeville be allowed to exempt from the provisions of proposition two and one-half, so-called, the amounts required to pay the \$12,725,000 principal amount, together with the amount necessary to pay all associated interest, on the bonds issued in order to acquire, by purchase, gift, and/ or eminent domain for active and passive recreation, agricultural, open space, and general municipal purposes, all or a portion of the parcel of land located at 44 Clear Pond Road, containing 138.10 acres more or less, and being described in a deed recorded with the Plymouth County Registry of Deeds in Book 40414, page 215, said parcel being owned by the owners thereof and now or formerly classified under G.L. c.61B, as described in Article 11 of the 2022 Annual Town Meeting Warrant?

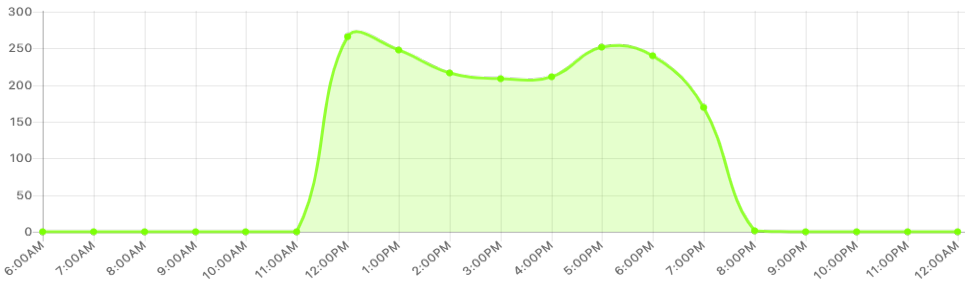

### NOTE: New Procedure to Check-In at the Special Town Election

To accelerate the check-in process at Lakeville's Special Town Election this year, check-in will now be accomplished by use of electronic Poll Pads. The use of these tablets will allow our election officers to check in a voter:

1. By manually entering the first three (3) letters of the voter's first and last name; or
2. By scanning the bar code on the back of the voter's driver's license. In this case, the Poll Pad matches the name and birth date of the person on the voter list with the name and birth date it reads from the bar code on the back of the license. No information from the scanned license is retained by the Poll Pad. The Commonwealth of Massachusetts does not require that a voter present a license to check in at any Elections and Town Meetings.

The Poll Pads immediately talk to one another, eliminating any chance of a voter checking in more than once.
